**Re: BMaddox Enterprises LLC v. Milad Oskouie, Osko M Ltd., and Platinum Avenue Holdings Pty, Ltd.**

The Defendants are in genuine need of requesting an extension from Honourable Judge Abrams and Magistrate Judge Cave in order to obtain representation and obtain due process.

I have attempted to obtain representation during this time, however, it has been made much more difficult due to a few hurdles: namely, 1) my dual citizenship with Australia and Iran 2) my inability to travel to the USA due to the travel ban in place and find / visit any lawyer, 4) some of the false and racist digital smears Mr Maddox has made against me and 5) the threatening actions and behaviours of the Plaintiff.

I have made attempts to hire numerous lawyers, however, nearly all have been reluctant to take on the case due to the sheer number of filings thus far and for the fear they themselves may become subject to the Plaintiff's wrath. One lawyer whom I intended to hire Richard Nacht initially agreed to work on the matter but after 2 weeks said he received a phone call "warning" him not to work on the matter.

Perhaps intentionally (or unintentionally), the Plaintiffs have outmaneuvered the legal system (ECF 174 and ECF 130) in order to deny me natural justice. The Plaintiff has been described by Australian Supreme Court Judge as "everyone's worst nightmare" "wholly arrogant" and "high handed" (ECF 174). The FBI have described his conduct as "...extremely disturbing..." (ECF 130 Ex C) and have gone to the extent of speaking to my family over concerns Mr Maddox may engage in something well beyond a digital smear or sending threatening letters out.

Put simply, the Plaintiff has discovered the nexus of harassing the defendants family via cryptic threats to actual threats of impending violence: "...*your sick sons last Ramadan*"(ECF 139 and ECF 139-A and ECF 139-B. In ECF 130-2), paralyzing social stigma by making false accusations of terrorism online (ECF 174), as well as engaging in blatant illegal hacking investigated by the FBI (ECF 130-C), and even threatening Defendants legal representatives and doctors (ECF 139 and ECF 130).

For most Defendants subject to such litigation and harassment of this kind, resistance is futile; most will reluctantly avoid defending themselves rather than have their names smeared online as well as have their very own mother and father suffer harassment.

Mr Maddox demonstrates his complete disregard for the judicial process when he states "**Attorney maybe expensive and time consuming**" (ECF130 Exhibit D and ECF 175) to one of the hackers and

suggests that hacking is more effective than taking any action via the legal system. Maddox asked the hacker named "Rabiul Islam" if it is "[p]ossible to hire you to focus efforts on getting ffltrust.com removed?". Rabiul Islam replied, "Shall I take down the site [FFLTrust.com] or only help your attorney to file the case?" In addition, Mr Maddox and Rabiul Islam decide to plant and concoct 'evidence' in my site and frame me: "...I can put together the evidence for your...However, it might will take more time to do that..." Mr Maddox is precisely guilty of the very thing he accuses me of. He has resorted to the use of a criminal hacker to help him "...put together evidence" and "help your attorney file the case". In ECF 56 at page 23, Mr Duff concedes to the accuracy of these screenshots and describes his client's actions to break the law by hacking his competitor as "...exploring his options..."

So now, copyright laws which were originally designed to compensate starving artists, allow bullying machine gun dealers and their attorneys in this electronic-media era to plunder defenseless foreign defendants.

Plaintiffs do have a right to assert their intellectual-property rights, so long as they do it right and not resort to illegal self help.

The Defendants respectfully petition for your cooperation pertaining to my request for an extension of 2 months to obtain representation given the peculiar circumstances I am in.

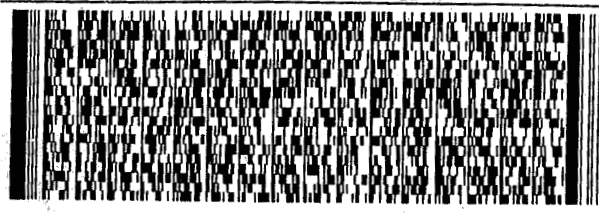

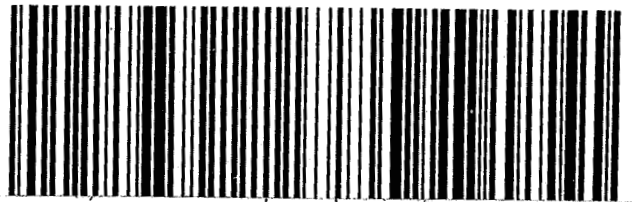
