DECLARATION OF ANDERSON J. DUFF IN SUPPORT OF PLAINTIFF AND COUNTERCLAIM DEFENDANTS' APPLICATION FOR ENTRY OF DEFAULT AGAINST OSKO M LTD AND PLATINUM AVENUE HOLDINGS PTY, LTD

I, Anderson J. Duff, state as follows:

1. I am an attorney of record for Plaintiff BMaddox Enterprises LLC and Counterclaim Defendants BMaddox Enterprises LLC and Brandon Maddox ("BMaddox") in the above-captioned matter, and I am familiar with the relevant file, records, and pleadings.

2. On March 3, 2020, the Court issued an order requiring the above-captioned parties Osko M Ltd and Platinum Avenue Holdings Pty, Ltd to file an appearance through counsel on or before Monday, May 4, 2020. (Dkt. No. 188.)

3. Neither Osko M Ltd nor Platinum Avenue Holdings Pty, Ltd has filed an appearance through counsel as of the date of this filing.

4. The Court's March 3, 2020 order expressly states that, if either Osko M Ltd or Platinum Avenue Holdings Pty, Ltd fails to comply with the order, BMaddox may seek a certificate of default from the Clerk of the Court. (Dkt. No. 188.)

5. Neither party against which BMaddox seeks an entry of default is an infant, in the military, or an incompetent person.

6. Both parties against which BMaddox seeks an entry of default have failed to enter an appearance as required by the Court's May 4, 2020 order.

7. The Court's May 4, 2020 order was properly served.


8. A proposed Clerk's Certificate of Default is attached as Exhibit A.
