Dear Judge Abrams,

I am writing to you directly regarding an urgent matter, since I have been unable to contact my own attorney to discuss this issue.

On the first of May 2018, Plaintiff's counsel submitted a declaration from Ehsan Hosseinzadeh falsely claiming that my doctor was not a doctor, amongst other false statements he made.

Plaintiff's counsel claimed that the declaration was from an Iranian lawyer. In reality, Ehsan Hosseinzadeh is not a lawyer in Iran. He falsely claimed to be a lawyer when, in fact, the official Iranian Bar has no record of him.

In his declaration, Mr Hosseinzadeh said claimed his Iranian Central Bar number was 24362. On the official Iranian Central Bar site, which Ehsan claims to be a member of, there is no record of him searching for this. This can be confirmed either by searching for him by name, surname or bar number. The website is publicly accessible to the world. I have attached two screenshots which evidence my findings.

It is now clear there is a pattern of hiring individuals with false credentials to make false statements to obtain an advantage by the Plaintiff's Counsel, as he did earlier this year in the submission of Mohammad Mahdi on 9 February 2018. It is unsurprising given that the Plaintiff's Counsel was once arrested, charged (felony), and prosecuted for breaking into a children's school. Candour to the court is something Mr Duff clearly does not value.

I kindly request that the Court accept this submission given the urgent circumstances.
