We refer to the above matter and to your email dated 11 March 2017. We thank you for confirming that you act on behalf of your client Mr Maddox. Our last and only correspondence emanating from our office to your client was dated 28 October 2016 and emailed on 31 October 2016. [brandon@FFL123.com]

To date we have **not** received the courtesy of a reply to our letter either from Mr Maddox or your firm.

Unfortunately, since October 2016 the situation has somewhat escalated or more precisely exponentially deteriorated, whereby your client Mr Maddox has truly crossed the proverbial Rubicon in not only ignoring our letter, but one would presume also ignoring his lawyers advice, by relentlessly embarking of his own accord in posting illegal, threatening, defamatory and false information about our client without first seeking legal remedy by resorting to appropriate civil and/or criminal courts.

As you are likely aware by now, upon your client's instigation and after protracted investigation of our client by the NSW Police Area Command, our client has been completely exonerated of any alleged criminal wrongdoing as claimed by your client (copy of Police email enclosed).

Despite this, we are instructed by our client of the fact that Mr Maddox has continued and is still currently continuing (as at the date of this letter) in resorting to illegal/criminal methods not only in openly defaming the good fame and character of our client, but also resorting to menacing and threatening language towards his person.

As a very small sample of the incriminating material posted by your client for the whole world to view, we enclose; (copy of one (1) page photo of our client and self explanatory defamatory particulars beneath the photo enclosed).

A further random samples of your client's petulant postings are, and we quote verbatim:

*".....These emails are being sent by an **Iranian** hacker by the name of Milad Oskouie. See AustralianHacker.com to learn more".*

OR

*".....These emails are being sent by an **Islamic** hacker by the name of Milad Oskouie. See AustralianHacker.com to learn more ".*

It is somewhat unfortunate, that this matter was not able to be resolved in a civil and amicable manner. We advise that we are now instructed as following:

1. Illegal threats/harassment/hate crime

We are to contact the following police forces:

- (i) Local, State & Federal police agencies in USA;
- (ii) AFP - Australian Federal Police;
- (iii) Scotland Yard and local police in Britain;
- (iv) Interpol - France.

We will provide a detailed brief to these police forces/agencies including all incriminating material relating to the internet breaches perpetrated against our client. As stated earlier, we have further material which we intend to provide to these respective police forces including a copy of this letter and our earlier letter to your client.

2. Defamation - Civil Law matter

We are to commence appropriate legal proceedings in defamation. As you can appreciate, contrary to your client having posted false and defamatory statements; - for the record; we reiterate that our client is a non-practicing junior lawyer, 30 years of age who currently resides in London, England. As a young lawyer he worked under a now Supreme Court Judge and an Investment Bank. As an ambitious professional young man, he has

suffered irreparable damage, and is continuing to suffer irreparable damage due to the illegal actions undertaken by your client.

3. Inappropriate contact with our client's parents

On 8 July 2016 your client had personally contacted our client's parents Mr & Mrs Oskouie, despite the fact that at that time, he had legal counsel representing him in the USA and Australia. Although, we do not act on behalf of Mr & Mrs Oskouie, we strongly suggest that you advise your client to immediately remove **all** postings, including statements/addresses/private and confidential information relating not only to our client, but also to his parents. As innocent third parties, we are amazed and saddened by the fact that your client had stooped so low by smearing the good fame and character of our client's parents.



Please be advised that we are in the process of collating our evidence. We will shortly draft our pleadings and be in a position to file our Statement of Claim with the Court. We will serve the same on your firm as legal counsel for the defendant Brandon Lane Maddox t/a BMaddox Enterprises,LLC in due course.
