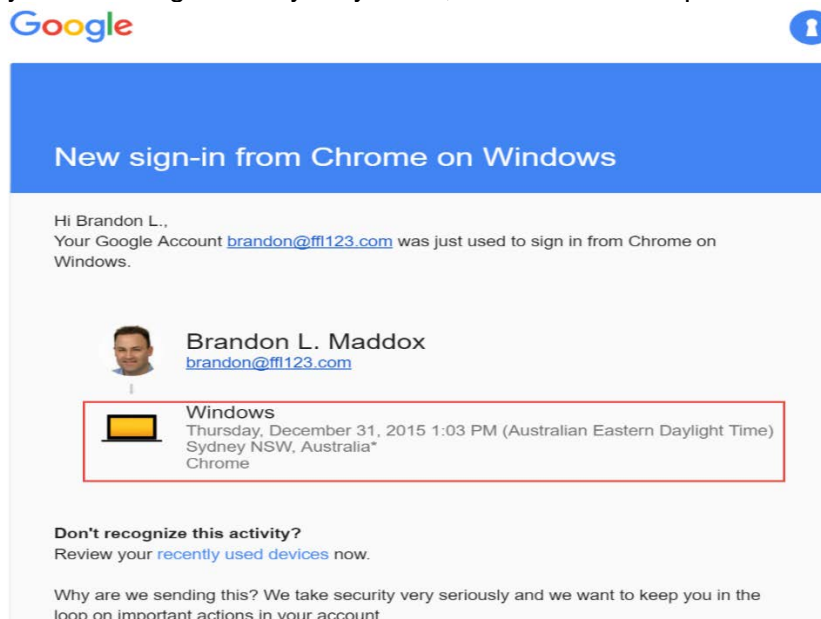
**Subject – Milad Oskouie**

My name is Brandon Maddox and I live in Sioux Falls, SD, USA; which is almost 9,000 miles away from your location. I am also a parent, with two young daughters.

I am a firearms dealer in the USA and have been for over 10 years. In 2005, I created a website, FFL123.com, to help other Americans get into the business of buying and selling firearms. This business puts food on the table for my family. I wrote this digital book based on my experience running my firearms businesses, which now has seven locations in the USA.

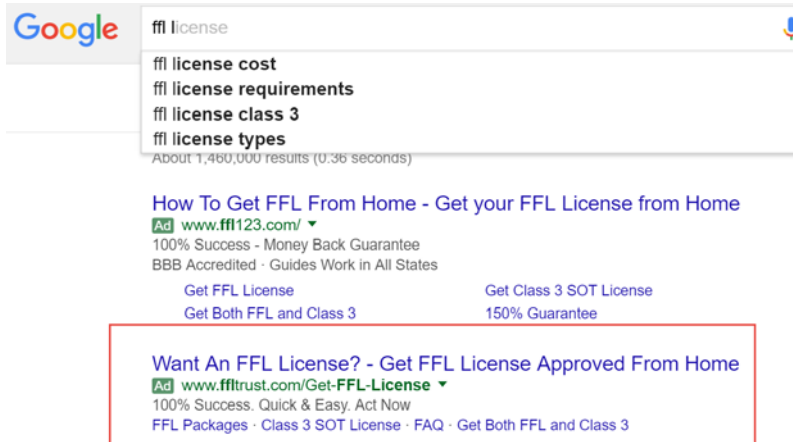
In late 2015, I started getting emails in the middle of the night alerting me that my personal and business online accounts were being accessed without my permission. The security alerts noted the activity was coming from "Sydney NSW, Australia". Example below...



My business is web based, so it relies on Google searched for traffic and sales. I noticed in late December 2015, Google stopped ranking my website in their searches. It took me a month to uncover that my website had been accessed without my permission and was changed to ask Google not to rank my website.



One February morning, I woke up and did a Google search and saw the following...



I reviewed the website at ffltrust.com and quickly identified the content was identical to my website, FFL123.com. I later learned this website, ffltrust.com, is owned and operated by Platinum Avenue Holdings Pty Ltd, which has a publically listed address of 8 Ward St Willoughby Sydney NSW 2068 AU and the sole owner is listed as Milad Oskouie.

You may ask, how do I know Milad? I kindly provided a free testimonial for him and a former business partner when they started a business in 2013.

I have hired legal counsel in the USA and Australia to help me resolve this unfortunate situation, I have spent over USD. I have met with local, state, and federal law enforcement agencies in the USA. The USA federal authorities have referred this case to the Australian Federal Police. I have coordinated with the Australian Federal Police through the US Embassy in Washington, DC and this is now being investigated by detectives through the Chatswood Police Station in NSW.

I hold very specialized licenses to deal in firearms. I am licensed to buy and sell military grade weapons. ffltrust.com has taken my licenses and altered them to appear as if they hold these licenses as well. See example below, the altered copy clearly shows my business name.
