Dear Sir,

We advise that we have spoken to our client Mr Milad Oskouie, and we have been instructed as follows:

1. On 16 December 2016 Central Standard Time (CST) our client was, and still is, in London England and not in Sydney Australia when the alleged unauthorised access was made.
2. Please note that our client's website did NOT "replace" Mr Brandon Maddox's at this time, for our client is a legitimate business competitor.
3. As mentioned previously in our telephone conversation; we have forwarded a two page email letter ( including annexure ) sent to Mr. Maddox on 31/10/2016 where he was asked to "**cease and desist immediately**" in his publically harassing, bullying and defamatory conduct against our client. To date we have NOT received the courtesy of a reply. As a result of Mr Maddox's somewhat strange, almost paranoiac behaviour, we are in the process of obtaining barristers advice with a view of suing Mr Maddox for defamation.
4. With respect to Mr Maddox, and without being too judgmental, his behaviour and actions are indicative of a person who thinks that he is in the " right "and that no other persons are entitled to conduct a competitive legitimate business. We strongly suggest that you do obtain a copy of our letter including annexure from Mr Maddox.
5. In regard to the "complaint" involving an alleged unauthorised modification of data with intent to cause impairment; contrary to Sec. 308D Crimes Act 1900, we would appreciate if you could forward to our office any/all evidentiary material that you have in order to specifically address any further outstanding concerns or issues.
6. Finally, since our client is of the view that these so – called " complaints ? " are not only frivolous, but are vexatious in nature with the sole purpose of stopping our client in conducting a legitimate business, we advise that we intend to rely on this letter and all other correspondence in any legal proceedings, including any arguments as to costs.
